5- Project description: One of the fish farming methods is cage breeding. Cage breeding is one of the most common methods of fish breeding that has been considered by most countries in recent years due to its special advantages, in which cages of different shapes and types are adapted to environmental and regional conditions and the species concerned are used. The use of polyethylene fish breeding cages in Iran was initially achieved in Bushehr province, the coast of Kangan, which in 2010 equaled 9 tons of fish farmed from two polyethylene cages weighing one thousand and 600 m3. This method was then developed in the prone areas. Chaharmahal Bakhtiari province is one of the major centers of cold fish production in the country. Due to its favorable fields and annual production of more than 24000 tons, it is considered the polar bear breeding ground in the country. Ardel County has about two fish farms in the province, which is Ardel County in terms of production and Kiar has the largest fish farms. The cage fish farming method has also been developed due to conditions in Karun 4 lake in Ardal city. According to the existing studies, the production capacity of fish in the lake cage behind the dam 4 is 4,000 tons, while the capacity in this lake is 4,000 tons, which in 2018 resulted in production of 3400 tons of fish.
